

# *New Hampshire School of Languages, Math, and Art*

## **Comprehensive Release and Waiver of Liability ("Release")**

This is a release of Liability. It affects your and your child's legal rights. Please, review it fully and carefully before signing. As used in this Release, the terms "Activity" and "Activities" include, by way of example but not limitation, the following, whenever and wherever may occur: indoor classroom activities (including instruction, games, dances, exercises), outdoor activities (including running, playing, jumping), concerts, plays, rehearsals, educational events, field trips, family nights, parties.

1. I understand that my child (name) \_\_\_\_\_ and/or I voluntarily participate in or attend any activity hosted, sponsored, or presented by, or in any way part of or related to New Hampshire School of Languages, Math, and Arts. I understand the risks and hazards involved and I recognize that injuries may occur while participating in these Activities whether caused by the passive or active negligence of New Hampshire School of Languages, Math, and Arts.

2. I understand that it is my responsibility and my child's responsibility to consult with a physician prior to and regarding participation in the Activity. I represent that we are physically fit and that neither of us have a medical, psychological, or any other condition which would prevent our full participation in the Activity.

3. I realize that liability may arise from the negligence or carelessness on the part of New Hampshire School of Languages, Math and Arts and its teachers, assistants, and volunteers. In consideration of being permitted to participate in the Activity, I agree on behalf of myself and my child to assume full responsibility for all risks, injuries, or damages, known and unknown, which I or my child might incur because of participation in the Activity.

4. In further consideration of being permitted to participate in the Activity, I knowingly and voluntarily – for myself and my children, my heirs, dependents, administrators, assigns, and legal representatives waive, discharge, hold harmless, and promise to indemnify and covenant not to sue New Hampshire School of Languages, Math and Arts and its teachers, assistants and volunteers and relinquish any and all claims that I or my child, or estate, or any person claiming under me completely and without reservation as a condition of my participation and my child's participation that I may have against New Hampshire School of Languages, Math and Arts, its teachers, assistants and volunteers from any and all injuries or damages of whatsoever kind and nature that I or my child may sustain as a result of participating in the Activity.

5. I understand that the Activities to which this Release applies may include risks of serious or life-threatening bodily injury, brain or cognitive injury, paralysis, or death, as well as emotional distress, pain and suffering, property damage, and economic losses. I understand and agree that no amount of instruction, precaution, and supervision can ever eliminate the risk of such injuries, losses, or damages. As part of this Release, I fully and forever acknowledge, accept, and assume the risk of all such injuries, losses, and damages to my child/children, my spouse, my relatives, and myself that may result from participating in or attending any Activity.
